A complete set of Bidding Documents in English language shall be purchased by interested bidders on submission of a written application to the **Deputy Director General, Expressway, Operation, Maintenance & Management Division, Road Development Authority, Kahatagahahena, Walgama, Bandaragama** from **16.05.2024** until **07.06.2024** during **09:00 hrs to 14:30 hrs** upon payment of a non-refundable fee of **Rs. 4,500.00 + Government Taxes** for the contract. The method of payment will be in cash. As per the **Public Contract Act No. 3 of 1987**, the **agent and successful winners of the tender shall be registered in the Department of Registrar of Companies.**
7. Each Bid shall be accompanied by a Bid Security obtained from a reputed bank acceptable to the Employer for an amount given in the Bidding Data. **Bid – Security shall be valid until 07/10/2024.**
