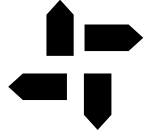

1. Bidding will be conducted through the **National Competitive Bidding Procedure**. A 5% preference will be given for Bidders who are registered within the North Western Province.

3. Pre Bid Meeting is scheduled to be held at the **Provincial Director's Office(NWP), Road Development Authority, Puttalam Road, Kurunegala** at 10.00 hrs on 10.06.2024 and site visit will be arranged on the same day.
4. It is **Mandatory for bidders to register under public contracts act no.03 of 1987**. For each contract (for contract value is more than 5 million) separately.
5. A complete set of bidding documents in English language may be purchased by interested bidders on the submission of written application, **registration form the Department of the Registrar of companies and CIDA book** to the **Provincial Director (NWP), Road Development Authority, Puttalam Road, Kurunegala** from 03.06.2024 until 17.06.2024 (**only week days**) from 9.00 hrs. to 15.00 hrs. upon payment of a non-refundable Tender fee (Above Table) for each document (**Excluding VAT**).

Bids mentioning the name on top left hand corner with separate envelopes shall be delivered in duplicate by registered post or hand to the **"The Chairman, Provincial Procurement Committee (NWP), Road Development Authority, Kurunegala"**, on or before 14.00 hrs. On 18.06.2024 late bids will be rejected.
7. Bids will be opened soon after closing, in the presence of the bidders or their representatives who choose to attend.
8. Bids shall be valid up to 16.09.2024

9. Bid shall be accompanied by a Bid Security. Bid Security shall be valid up to **14.10.2024**.
