- The successful bidder shall submit a Performance bond as per the specimen for the value of 5% of the award from a Bank in Sri Lanka, acceptable to the Road Development Authority.
- Contractors who pay VAT, must state the VAT number and attach a copy of the VAT registration certificate with the bid document.
- All machinery (Bitumen Sprayer, Air Compressor, Paver, static roller, PTR, etc...) required for laying and compacting asphalt concrete shall be provided by the contractor.
- Bids shall be valid up to 23/09/2024.
- Bids shall be delivered in duplicate to the Chairman, Regional Procurement Committee (Sabaragamuwa Province), Road Development Authority, No 04, Bandaranayaka Mawatha, Ratnapura on or before 14:00 hrs on 08/07/2024.
