2. Bidding will be conducted through the National Competitive Bidding Procedure.
3. To be eligible for contract award, the successful bidder shall not be blacklisted.

A complete set of Bidding Documents in English language shall be purchased by interested bidders on submission of a written application to the **Deputy Director General, Expressway Operation, Maintenance & Management Division, Road Development Authority, Kahatagahahena, Walgama, Bandaragama** from **22.07.2024** until **05.08.2024** during **09:00** hrs to **14:30** hrs upon payment of a non-refundable fee of **Rs 23,000.00** + Government Taxes for the contract. The method of payment will be in cash. As per the **Public Contract Act No. 3 of 1987**, the **agent and successful winners of the tender shall be registered in the Department of Registrar of Companies.**

Bid shall be delivered in duplicate to the Chairman, Road Development Authority Procurement Committee, C/o **Deputy Director General's Office, (Procurement) 4<sup>th</sup> Floor, 'Maganeguma Mahamedura, Denzil Kobbekaduwa Mawatha, Battaramulla** on or before **14:00** hrs on **06.08.2024**. Late bids will be rejected. Bids will be opened soon after the closing, in the presence of the bidder's representatives who chooses to attend at the address below.
